

**LEGAL NOTICE
TOWN OF LEBANON
ANNUAL TOWN MEETING**

Pursuant to Connecticut General Statutes Section 7-1, et seq., public notice is hereby given to the Electors and those qualified to vote at the town meetings of the Town of Lebanon that the Annual Town Meeting will be held on Monday, May 7, 2007 at 7:30 P.M. in the Lyman Memorial High School Auditorium, 917 Exeter Road (Route 207) Lebanon, Connecticut, to:

1. Conduct Award Presentation as requested by the Lebanon Volunteer Fire Department.
2. Consider and act upon the proposed 2007-08 Fiscal Year Budget for the Town of Lebanon of twenty one million four hundred forty one thousand seven hundred eighty three dollars and no cents (\$21,441,783.00) for the General Town Government, Board of Education, and Special Revenue Funds, with Revenue Estimates of eight million three hundred seventy thousand one hundred ninety four dollars and no cents (\$8,370,194.00), and the remainder to be raised by taxes, with an estimated mil rate of 26.4 mils, a 4.3% increase, and to adjourn Item 2 to Referendum to be held, unless such date and times are altered by the Town Meeting, on Tuesday, May 15, 2007 between the hours of 6:00 A.M. and 8:00 P.M. Electors and persons qualified to vote in town meetings who are not electors, shall vote at the Fire Safety Complex, 23 Goshen Hill Road, Lebanon, Connecticut.
3. Consider and act upon, if Item #2 is approved at Referendum, the proposed appropriation of up to one million thirteen thousand one hundred twelve dollars and no cents (\$1,013,112.00) to the Capital Reserve and Non-recurring Expenses Fund of which up to eighty four thousand three hundred sixty eight dollars and no cents (\$84,368.00) are to come from available unallocated or reallocated funds and the remainder to come from the 2006-2007 Fiscal Year budget appropriation.
4. Consider and act upon appropriating up to \$2,275,000.00 for the purpose of constructing a Senior Center in the Town of Lebanon, \$1,500,000.00 from designated accounts including the Hugh Trumbull Adams Fund (Account #218), STEAP Grant Fund, Small Cities Development Block Grant Fund; \$400,000.00 from unencumbered Fund Balance and \$187,500.00 to be raised by taxes in FY 07-08 and \$187,500.00 to be raised by taxes in FY 08-09, with mil rate impact not to exceed 0.4 mils in each fiscal year, and to adjourn Item 4 to Referendum to be held, unless such date and times are altered by the Town Meeting, on Tuesday, May 15, 2007 between the hours of 6:00 A.M. and 8:00 P.M. Electors and persons qualified to vote in town meetings who are not electors, shall vote at the Fire Safety Complex, 23 Goshen Hill Road, Lebanon, Connecticut.
5. Consider and act upon approving the 2007-08 Fiscal Year Local Capital Improvement Program (CIP) as proposed by the Board of Selectmen and endorsed by the Board of Finance.
6. Consider and act upon an Inter-municipal Agreement between the Towns of Colchester and Lebanon for the maintenance and repair of a shared municipal road.
7. Consider and act upon accepting a gift in the amount of \$10,000.00 from Oliver and Lucille Manning for the purposes set forth in a certain gift letter dated February 13, 2007 and to authorize the Board of Selectmen to administer said funds.
8. Consider and act upon re-designating previously allocated funds provided by the Lebanon Lions Club for the purpose of a Teen Center and releasing said funding to Lebanon Connecticut Little League, Inc. for the purpose of Recreation Area improvements on Bascom Road as requested by the Lebanon Lions Club.
9. Consider and act upon a new Ordinance Concerning Membership of Town Employees on Town of Lebanon Land Use and Finance Boards and Commissions.
10. Consider and act upon a revised Ordinance Providing for the Appointment of Constables for the Town of Lebanon in Lieu of Constables to be Elected at the Regular Town Election.
11. To consider and act upon any other business proper to come before said meeting.
